

Young & Free Ontario Drop Zone Contest Rules

CONTEST PERIOD

- Monday, August 1, 2011 to the close of business Wednesday, August 31 2011.

HOW TO ENTER

- No purchase necessary.
- To enter the contest visit <http://www.facebook.com/YoungFreeOntario> during the contest period and follow the instructions provided to post or link to an applicable image or video. Only one such entry is allowed per person.
- Go Free Bundle members at Libro Financial Group or United Communities Credit Union will earn an additional entry to the contest.
- If it is discovered that you attempted to enter more than the eligible number of entries as defined, all of your entries will be declared null and void, and any prize you might have been entitled to will be forfeited and awarded to the next eligible entrant. Entries generated by script, macro, robotic, programming, or any other automated means are prohibited and will be disqualified.
- Libro Financial Group, United Communities Credit Union, and Currency Marketing staff, credit union elected representatives, and Board of Directors members and immediate family members living in the same house are not eligible to enter the contest.
